**Course Overview and Description**: Candidates will learn to teach Social Studies through the application of the writing process, reading/writing connections, and children's literature. The overall goal of EDUC 5312 is to prepare candidates to assume their roles as professional educators who positively impact the social studies learning of all students.

- 1. Recognize the importance of Social Studies to the elementary/secondary school learner.
- 2. Develop teaching strategies for addressing learning goals in social studies.
- 3. Develop instructional strategies that stress literacy, cultural proficiency, student thinking, and real-life connections.
- 4. Locate high-quality resources and materials for teaching social studies.

#### **Student Learning Outcomes (SLOs)**

- 1. Student will demonstrate strong understanding of current literature in developing courses and interdisciplinary practices in ELA/SS.
- 2. Students will explore and provide insight to peers, through analysis of the latest research-based practices in SS classrooms.
- 3. Students will create a themed social studies center that is interdisciplinary in nature and incorporates geography and arts' activities into the SS classroom.
- 4. Students will acquire a deep understanding of how literature circles enhance K-12 students' understanding of other cultures, time and change, and global connections. Students will develop and implement a literature circle.

Authentic Assessment, Course Design: Personal Collage (88 pts.)- Students will create a collage about themselves that illustrates their knowledge of their own historical context/frame of reference (48 pts.) and then design a graphic to teach students about historiography skills such as evidence, source, and primary and secondary sources (40 pts.). \*\*Supports the Dept. of C&I Goals #2, 4, & 10, Student Learning Outcomes #5, and ISTE Technology Standards 7a, 7b, 7c.
- b. # **OTHER POLICIES**

#### **Class Attendance**

Regular, punctual attendance, documented participation, and submission of completed assignments are expected at all classes, field experience, and other activities for which the student is registered. Failure of students to adhere to these requirements may influence the course grade, financial assistance, and/or enrollment status. - **A. Personal Days**-Students are expected to attend all classes, arrive on time, sign in, and actively participate in class, including online courses. Students are allowed **two "personal days" of absence that they may take at their discretion, but only with prior notification**. You may notify the instructor by phone, email, or during class time.
- **B. # To complete Certification/Licensing Requirements in Texas related to public education and other professional settings:

1. Candidates must undergo a criminal history background check prior to clinical teaching and prior to employment as an educator. The public-school campuses are responsible for completing the criminal background check. A person who is enrolled or planning to enroll in a State Board for Educator Certification-approved educator preparation program or planning to take a certification examination may request a preliminary criminal history evaluation letter regarding the person's potential ineligibility for certification due to a conviction or deferred adjudication for a felony or misdemeanor offense.

A Preliminary Criminal History Evaluation is a non-mandatory, non-binding evaluation of an individual's self-reported criminal history. In addition, the agency obtains your name-based Texas criminal history information. The service is provided to the requestor for a **non-refundable fee**. The requestor will receive an evaluation letter by email from agency staff advising of potential ineligibility for educator certification.

You are eligible to request a Preliminary Criminal History Evaluation if:

- You enrolled or planning to enroll in an educator preparation program or
- You are planning to take a certification exam for initial educator certification, and

• You have reason to believe that you may be ineligible for educator certification due to a conviction or deferred adjudication for a felony or misdemeanor offense.

You are not eligible for a preliminary evaluation of your criminal history if you do not have a conviction or deferred adjudication for a felony or misdemeanor offense.

<u>In addition, you must complete the fingerprinting process when you apply for certification.</u> Participation in the evaluation does not preclude you from submitting to a national criminal history review at the time you apply for your educator certification. Your criminal history will be reviewed and you may be subject to an investigation based on that criminal history, including any information you failed to submit for evaluation.

2. Provide one of the following primary ID documents: passport, driver's license, state or providence ID cards, a national ID card, or military ID card to take the TExES exams (additional information available at <a href="www.texes.ets.org/registrationBulletin/">www.texes.ets.org/registrationBulletin/</a>). YOU must provide legal documentation to be allowed to take these mandated examinations that are related to certification/licensing requirements in Texas.

As a teacher, you are responsible for helping students learn and grow. What you do as a teacher will make a difference in students' lives. There is much to do to prepare for taking on the demands of leading a classroom so we ask you to put in your best effort. This class will require you to stay on top of your work. If you find yourself stumbling, overwhelmed, or generally stressed out, that's a signal to get in touch with me. We will set up a time to meet or talk. I will offer support and try to figure out how to help you balance these demands and learn so that you are prepared to teach.

#### Discussions

Discussions will take place with class members outside of class and during class. I expect you to share your ideas, listen to and try to understand the ideas of others, ask each other questions about the topic of discussion and ideas shared, build on each other's ideas, cite examples from the texts or your experiences to support your ideas, and treat each other with respect. As a participant in discussions, do what you can to encourage your peers to participate, move the discussion forward, and make the classroom safe for different perspectives.

Consider the following behavioral practices to support active listening as you participate in class: Good practice includes looking at the person who is talking to you; making an effort to hear the exact words the speaker is saying; reflecting back what you hear; responding to others' ideas by extending, supporting, or challenging those ideas with your own thoughts; using specific examples from course readings to support your ideas or connect to the ideas of others; and use nodding or other signs to show that what a classmate says matters.

Some cautions to avoid include interrupting before the person has finished speaking, being preoccupied with other things, conveying immediate disagreement or impatience by how you look at the person, or quickly suggesting other perspectives without understanding those of the speaker.
